COMMITTEE ACTIVITIES

CSWEP met on October 2, 1981 in the office of the Chair, Elizabeth E. Bailey. In attendance besides the Chair were Committee Members: I. Adelman, M. L. Curley, R. Eisner, J. Goulet, J. Haworth, B. Jones, H. Ladd, N. Ruggles and J. Shackelford. Also attending was G. Wilensky of Washington Women Economists. H. Ladd recorded the proceedings. Highlights from her report follow:

Report on the Econometric Society and Women

Robert Eisner reported on the small number of women involved in the Econometric Society's activities and the Society's response to allegations of discrimination against women and other minority groups. He noted three parts of the problem -- the small number of women who have published in Econometrica (a review of articles contributed between 1952 and 1980 revealed that there were only 32 articles authored or co-authored by women and only 21 female authors), the small number of women participating in Econometric Society activities, and the limited representation of women in the prestigious Econometric Society of Fellows.

Because of the importance of encouraging women to enter the statistical and quantitative fields within the profession, the Committee directed Robert Eisner and Irma Adelman to pursue the following strategies: (1) encourage the Society to send invitations to women to join the Society and offer to provide address labels of women in appropriate fields, (2) suggest that the Society advertise in the CSWEP Newsletter, (3) attempt to increase the number of women organizers of Econometric Society sessions (Note: Several of our members have reported to CSWEP that both AEA and the Econometric Society have agreed to sponsor sessions which these women organized on their own and submitted for consideration. We urge other members to follow their footsteps); and (4) secure the endorsement of prominent fellows for the nomination of female fellows during the next few years.

CSWEP Sponsored Session

Call for papers and/or abstracts for CSWEP sponsored session at AEA Meeting in New York, December 1982.

Two topics have been suggested: "Equal Pay and Comparable Worth" and "Women and Health". Joan Haworth is helping to coordinate the first and Gail Wilensky the second (see page 15 for their addresses and phone numbers). Provided there is sufficient interest, CSWEP will sponsor both sessions. The better of the two (in terms of quality of papers submitted) will be published in the Papers and Proceedings of the AEA.

Deadline for Submissions: Early December 1981.

NBER Conference on Women

Irma Adelman reported on the status of the conference on issues related to women that she had proposed to the NBER. A planning committee has been organized to put together a 4-10 paged document with subjects, authors, and a brief description of the papers. The proposal would then be submitted to NBER who would find funding for it. The planning committee will meet in Washington, D.C., on December 3; any suggestions should be sent to Gail Wilensky (see page 15 for her address and phone number).

Committee Members

Chair Bailey announced that Monique Garrity of the World Bank and Gail Wilensky of the National Center-Health Services Research would join the Committee on January 1982. M. Garrity will perform the functions of Secretary and Treasurer and G. Wilensky will represent CSWEP Washington. Barbara Jones and Helen Ladd will be leaving the Committee at the end of this year, having served us well for the past three years. A list of the 1982 CSWEP membership with addresses and responsibilities is shown on page 15.

Report on Data on Women Economists

CSWEP is undertaking an analysis of four sets of data that may aid us in understanding the status of women in our profession -- the CSWEP file of approximately 2,200 records, the AEA Directory file of 20,000 records, the JEL tapes of articles and their authors which include about 10,000 records per year, and the membership directory of the Washingtom Women Economists. Joan Haworth is in charge of this project. She is finding that while the AEA information is suitable for Directory purposes, it is not valuable for CSWEP analysis. The sex indicator is missing in about 40 percent of the cases, the highest degree is difficult to determine from AEA records, and there are other difficulties with coding. It appears that any analysis we undertake will have to compare women in the CSWEP file with all economists (including women) in the AEA file.

In addition to these data sources, Elizabeth Bailey has compiled a list of women economists in the Chairpersons Group of Universities, by rank and field. This list is available from her office for any members that are interested.

Report on Roster

Nancy Ruggles described her work with the CSWEP Roster which is now at Yale University. She has created a master file that is sufficiently openended and flexible to permit the easy addition of new material. She has received about 800 responses to the update questionnaire sent out in August. Although she had hoped for more responses (we have over 2,000 women economists in our CSWEP files), she still plans to put out the printed roster in November in time for the fall recruiting season. We are extremely excited by this printing of the roster. For the first time, the roster will be widely available at a reasonable price to all our members as well as to their actual and potential employers. This culminates over a decade of painstaking work.

Report on Dues

The committee agreed that in the future, a March mailing should include both the dues notice and the questionnaire update. Report on CSWEP Membership

Analysis of CSWEP files suggest that we are not doing well in recruiting young women. The Committee recommended that a letter be sent to all major universities requesting a list of their current female graduate students and that a follow-up letter be sent each year to obtain names of the new female students. The Committee agreed that the letter should include information about the current structure of CSWEP, should explain some of our activities, and should point out the advantages of receiving the Newsletter and the roster.

Report on Washington Women Economists Task Force

Washington Women Economists, a professional network of 400 women, has has set up an economic task force which will be available to legislators, policymakers and news media as a resource on critical economic issues as they affect women. The task force will be preparing position papers on current economic issues and commentary on pending legislation.

The task force is trying to locate women economists who are working in areas likely to be considered in the current and upcoming sessions of Congress. These include: changing minimum social security benefits, eligibility changes for food stamps, AFDC and other public entitlement programs, the effects of high interest rates on the availability of credit to women, economic implications of reducing legal aid services, the relationship between economic slowdowns and various population groups, etc.

CALLS FOR PAPERS

International Conference on Forecasting Regional Population Change and its Economic Determinants and Consequences. Sponsored by the American Statistical Association and the U.S. Bureau of the Census under a grant from the National Science Foundation. This conference will assess the theory and methods of modeling economic-demographic interrelationships on the subnational level, assess data sources and identify data problems and potential improvements in the data base, and recommend new directions in theory and methods. Emphasis on the conference is on forecasting.

Individuals wishing to present a paper must submit an explicit two-page abstract and a resume including a list of publications.
