Roster Update

The roster now reflects all the information provided by those of you who responded to our recent updating survey. Thank you for your cooperation and please remember to suggest our roster employment service whenever hiring decisions are made.

Many of you questioned the use of a 0-1 code reflecting membership in CSWEP. All women economists on our roster are automatically associate members of CSWEP and coded as "1". Non-economists and men who receive the newsletter are not associate members and, hence, are coded "0". The code was hand-corrected on all survey responses which were not filled out accordingly.

The Secretary of Labor invites people to submit papers by September 30, 1977 on the employment experience of mature women for a conference to be held in late January 1978. The conference is the second in a series called to examine the results of longitudinal surveys of the labor market, covering the period 1967 -1974. These data are available on computer tape and in a report covering the first five years (1967-1972), entitled Dual Careers: A Longitudinal Study of Labor Market Experiences of Women, Volume IV. The submitted papers will be examined by a committee of experts who will choose at least five. The following criteria will beused in the selection of papers: (1) relevance of research for the development of more effective policies and programs within the Department of Labor and elsewhere; (2) methodological competence; (3) imaginative use of the data; and (4) conciseness and clarity of exposition. On Saturday, April 23, 1977, the academic conference of the Barnard College Women's Center in New York will hold a meeting to consider the impact of feminism on traditional modes of scholarship. Diana Long Hall will give a case study of the way knowledge in a new field, sex endocrinology, develops in the context of implicit assumptions about science and about the nature and roles of women and men. May Payer will provide an analysis of broader social and theoretical implications of the specific day-to-day scientific and scholarly practices discussed by Hall. CSWEP sponsored a hospitality room at the Employment Meeting in January in Chicago, and we wish to thank all those who helped in this successful effort.

<u>International Women's Year Decade Issues</u>. At the request of Congress, American women have been asked to organize a statewide meeting in each of the 50 states to, "Identify the remaining barriers to full equality for women," and to make legislative recommendations based on a consensus about these problems.

Many of the state meetings are being held in June, but the times vary so watch for announcements in your state. Issues identified in the state meeting will be taken to a national meeting to be held in Houston, Texas in November 1977 and then will be presented at the next session of Congress in January 1978, as mandated by the public law under which the Conference is organized.

Through this process, there is an opportunity to get Congress' ear on key issues for business and professional women as well as women in other fields and for full-time homemakers.

Clearly, women economists will want to be part of this effort. You may want to participate in planning, and organizing workshops, and exhibits and of course go to your state meeting. You undoubtedly are concerned with the continued sharp earnings gap between women and men, the ever present occupational segregation by sex, and failure of affirmative action programs in virtually all institutions including corporations and universities, the continued disinterest of institutions in the special problems of the working mother and woman-headed household, plus a host of problems in social security pension benefits and tax matters which discriminate against women who earn salaries or fees for work outside the home, and women who often are financially neglected for years of work inside the home.

HERS-New England, Higher Education Resource Services, is prepared to organize and present career counseling workshops in college or university teaching and administration for pre- and postdoctoral women, in regions of the United States where a need for such services is expressed, and where the facilities and support services of an appropriate institution are provided.

Project HERS was founded in 1972 to improve the status of women in higher education. It has created a national network of professional women, and maintains a talent bank of academic women in all fields of teaching and administration, operates a search, referral, and placement service, and provides academic career information services. HERS is the action arm of the Committee for the Concerns of Women in New England Colleges and Universities, a group of experienced women faculty and administrators. Higher Education Resource Services-New England is now located at Wellesley College.

Having identified the growing need of academic women in all fields to receive career information beyond that offered by existing services and networks, HERS has sought and obtained funds to support two types of career counseling workshops and career cooperatives for academic women: a) for doctoral candidates and postdoctoral fellowship holders seeking first academic job placements, and b) for postdoctoral women in junior-level appointments seeking to improve their chances for permanent positions or for administrative advancement.

HERS calls upon all interested colleges, universities, women's centers, professional women's caucuses, and other organized groups, to propose such career counseling workshops, to be held at their institutions. Where appropriate several such groups may pool their efforts to hold a workshop at a single institution. HERS will select sites and organizations which invite its free service of running career workshops for academic women, according to the following criteria: all proposals should be addressed c/o D.r Lilli Hornig, Project HERS, Wellesley College, Cheever House, Wellesley, Mass. 02181, and should arrive no later than April 29, 1977. Final selection will take place on or before May 31. The workshops should be scheduled during the academic year 1977-1978, but no sooner than October 15, 1977.
