Dear Fellow Economists:

You will note listed below the new members of the 1978 Committee on the Status of Women in the Economics Profession. Ann Friedlaender has taken over as Chair from Barbara Reagan whose term ended in December. Barbara served as chair from 1974 to 1977 and we owe her a huge debt of thanks for her tireless efforts and for the progress the Committee has made under her guidance. Marianne Ferber and Ruth Shaeffer have joined the Committee as regular members and Tjalling Koopmans as ex-officio member in his capacity as President of the Association.

COMMITTEE ACTIVITIES

At the annual AEA meeting in New York, CSWEP had a hospitality room for women economists and other visitors. In addition to coffee and conversation, a listing of job opportunities as of December 1977 was provided for those interested.

In program session sponsored by CSWEP three papers were presented on the subject: "The Effects of the Increased Labor Force Participation of Women on Macroeconomic Goals." They were: The Effects of Economic and Demographic

The CSWEP open meeting was held with approximately forty people attending. Barbara Reagan presided. After giving a brief history of CSWEP, she introduced present and past committee members. She then turned the meeting over to Ann Friedlaender as incoming 1978 Committee Chairperson.

Janice Madden gave a report on the roster, including information about sales and update of the roster. Ruth Shaeffer reported on efforts to increase CSWEP's contacts with women in business. Mariam Chamberlain reported on the content, cost and mailing of the Newsletter. In the absence of Gloria Shatto and Joan Hayworth, regional representatives for the Southern region, Barbara Reagan reported on CSWEP participation at the Southern Economic Association meeting in New Orleans. A very successful joint session was held and similar participation for other regional meetings was recommended. Barbara Reagan also reported on the results of the Reagan-Strober work on the occupational status of women economists done under CSWEP auspices. A full report of the 1977 activities of the Committee will be published in the Proceedings issue of the American Economic Review.

Following the presentations by Committee members, discussion was invited from the floor on the following issues: (1) the Newsletter, with or without job notices, (2) dues, (3) regional activities, (4) the types of sessions CSWEP should sponsor, and (5) the position of the Executive Committee on the ERA. Most of the discussion revolved around the last item.

On December 16 CSWEP had sent a letter to the Executive Committee of the ERA requesting the Association to join other professional associations in refusing to hold meetings in states that have not ratified the ERA and to relocate the 1978 annual meetings scheduled for Chicago and the 1979 meetings in Atlanta. The Committee refused to consider the request on the ground that it would constitute a political act in violation of the by-laws of the Association. CSWEP then decided to put the matter on the agenda for discussion at the open meeting and the question of possible strategies for further protest was taken up. One suggestion was to boycott the meetings, but this was rejected as harmful to women since it would exclude them from the program and from the job market. The course of action agreed upon was to ask members to write letters to Tjalling Koopmans as President expressing their views and urging that the sentiments of the membership of the Association be considered in choosing future convention sites.

With regard to other items on the agenda the following comments were made. The Newsletter should be continued although the value of the job listings is questionable. The possibility was raised that if the job listings were included, the Newsletter could be mailed by a more timely method. CSWEP regional activities should be pursued.

Other activities might include efforts to recruit women into the economics profession.

Following up on the recommendation to pursue regional activities, CSWEP will participate in the meetings of the Eastern Economics Association to be held in Washington, D.C., April 27-29. Plans include an organizational meeting, to be followed by an informal social hour with refreshments, and also a display booth in the book exhibit section.

As announced in the last Newsletter, the Committee is conducting a survey of ongoing research by associate members. A few returns have come in but we need to hear from more of you about your research in progress. Among other things it would be helpful to have this information on file since the Committee is frequently asked to suggest individuals for speakers, memberships on advisory groups, etc. If you have not already done so, please provide, preferably on a 3x5 card, the following information:

NEWS FROM WASHINGTON

A group of fifteen women in the U.S. House of Representatives have recently announced the formation of a Congresswomen's Caucus. The Caucus is a bi-partisan group that expects to play a role as a strong advocate of issues affecting women. The Co-Chairs are Margaret Heckler, Republican, of Massachusetts and Elizabeth Holtzman, Democrat, of Brooklyn. Among the issues of concern to the Caucus are the treatment of women under Social Security, spouse abuse, child care and part-time opportunities for women. Another area of concern is the advancement of women in public employment. The Caucus expects to develop a research capacity to deal with these and other issues relating to women.

In January of this year, the Women's Bureau of the Department of Labor was transferred from the Employment Standards Administration to the Office of the Secretary. Its new position as part of the Secretary's Office will serve to strengthen the policy making capacity and advocacy role of the Women's Bureau. Among the new functions of the Bureau, according to Secretary Ray Marshall, will be to develop pilot projects to improve the training and employment of women. Approximately \$2 million has been allocated for this purpose. Under its Director, Alexis M. Herman, the Bureau will also continue its clearinghouse, coordination and technical assistance functions as before.

The latest tally of Presidential appointments by the Carter Administration lists 842 persons of whom 152 or 18 per cent are women. Details are given in the February 6, 1978 issue of the Presidential Personnel Plum File, available through the G.P.O.

CONFERENCES

The last Newsletter noted an upcoming conference sponsored by the Secretary of Labor on the National Longitudinal Surveys of Mature Women. The Conference, which was coordinated by Isabel Sawhill, took place in Washington on January 26-27 with over 150 people attending from government, academia and various private organizations. The Conference was designed to bring research to bear on policy, to stimulate researchers to think more about the policy implications of their work and to communicate the needs of policy makers to scholars working with these data. The keynote address was given by Secretary Ray Marshall, seven research papers were presented for discussion and a summary report by Isabel Sawhill concluded the proceedings. The papers were the following: "The NLS Mature Women's Cohort: Socioeconomic Overview," by Frank Mott, Center for Human Resource Research at Ohio State University; "Research Uses of the NLS Data on Mature Women," by Clifford B. Hawley, Department of Economics, University of South Florida, and William T. Bielby, Department of Sociology, University of California at Santa Barbara; "Sex Role Attitudes and Employment Among Women: Dynamic Models of Change and Continuity," by Anne Statham Macke, Department of Sociology, Ohio State University, Paula M. Hudis, Department of Sociology, Indiana University and Don Larrick, Department of Sociology, Ohio State University; "Employment Income, and Family Life: The Case of Marital Dissolution," by Andrew Cherlin, Department of Social Relations, Johns Hopkins University; "Economic Consequences of Marital Disruption," by Lois B. Shaw, Center for Human Resource Research, Ohio State University; "The Impact of the Unemployment Rate on Labor Force Entries and Exits," by Francine Blau, Institute of Labor and Industrial Relations, University of Illinois; "How Can We Explain the Apparent Sex Similarities in Occupational Status Attainment," by Neil Fligstein and Wendy Wolf of the Department of Sociology, University of Wisconsin. A report of the proceedings will be available later this year.

The Census Bureau is sponsoring an invitational conference on Issues in Federal Statistical Needs Relating to Women. The conference is the first of its kind designed to examine data needs and concepts relating to the status of women in order to ensure that useful information is obtained. It is hoped that discussion of these

issues by data suppliers and data users will result in a better understanding of current deficiencies and revisions needed. Topics will cover all Federal statistical sources on the impact of changing family structures, income and occupation, health and education. The Conference will take place April 27-28 in the Washington area. The national coordinator is Barbara Reagan. Some of you may have read or heard in the media about the White House Conference on Balanced National Growth and Economic Development that took place over a five day period beginning January 29. About 500 people attended. Barbara Reagan was asked to serve on the National Advisory Committee. The Committee is now charged with the preparation of the follow-up report of the conference for submission to the President. The conference chairman was Governor John Rockefeller of West Virginia.

GRANTS AND GRANT OPPORTUNITIES

Babson College is sponsoring the Edward L. Bernays Foundation award for a practical program to achieve economic justice for homemakers. With a grant from the Monticello College Foundation, the Newberry Library (The Family and Community History Center) is offering a six month fellowship for work in residence. The stipend is \$6,500. Applicants must have their Ph.D. The award is designed primarily for younger women whose work gives promise of scholarly productivity and whose career would be significantly enhanced by six months of research and writing. Preference will be given to applicants concerned with the study of women but study may be proposed in any field appropriate to the Newberry's collections. Internship Program for Women and Minorities in Educational Research and Related Disciplines. The National Institute of Education has funded HERS mid-Atlantic (Higher Education Resource Services) to conduct a feasibility study regarding the development of a one year internship program designed to increase the number of talented women and minority educational researchers and to encourage the pursuit of fresh educational research related to their special concerns. This program is directed toward junior faculty members in the colleges and universities in the mid-Atlantic region. Under the proposed internship plan, the junior faculty chosen as interns would be placed with outstanding senior researchers on a continuing research project within established research institutions or college departments. National Consumer Affairs Internship Program. This program is for graduate students at American colleges and universities to intern in consumer affairs offices in government, industry and non-profit associations. In 1978 thirty interns will be selected in each of three classes: Class I - January-April 1978; Class II - May-August 1978; Class III - August-December 1978. Applicants must be nominated by a faculty member who is willing and able, if the candidate is selected, to arrange for internship credit, serve as faculty adviser and participate in the pre-internship conference. Interns receive a \$1,500 stipend and faculty members \$100 for their services. Travel expenses are also reimbursed. This Program is a joint project of the American Council of Consumer Interests and the Conference of Consumer Organizations and is administered by the Community Services Center, Continuing Education Division, University of Arizona. PUBLICATIONS OF INTEREST

Last fall the Congressional Subcommittee on Economic Growth and Stabilization of the Joint Economic Committee held a hearing on what it termed the "massive" entry of women into the labor force. A compendium of papers prepared in conjunction with the hearing has been published and may be ordered from the Superintendent of Documents. It is entitled American Women Workers in a Full Employment Economy.

A compendium of papers submitted to the Subcommittee on Economic Growth and Stabilization of the Joint Economic Committee. September 15, 1977 (\$4.50). The compendium consists of seventeen papers dealing with the past, present and foreseeable job roles of women.

The Conference Board has announced a series of regional workshops on improving job opportunities for women based on two new research reports on corporate affirmative action efforts. The reports are entitled Improving Job Opportunities for Women, A Chartbook Focusing on the Progress in Business and Improving Job Opportunities for Women -- From a Corporate Perspective. Both are in press. They present the results of a study conducted at the Conference Board by Ruth Shaeffer, who is the co-author of the first volume (with Helen Axel) and author of the second.

In a new book entitled Equal Pay in the Office, Francine Blau examines salary differences among men and women in similar jobs. She finds that for the most part such pay differentials are primarily the result of differences in pay rates among firms rather than pay rates within firms. A series of 51 booklets exploring the legal status of homemakers in each state and in the District of Columbia has been completed under the sponsorship of the International Women's Year Commission. The homemaker studies identify inequities in laws concerning inheritance, property rights, support and alimony, rape and spouse abuse and legal penalties relating to adultery.
