CSWEP wrote to both the Democratic and Republican Campaign Headquarters before the November election urging the candidates to consider qualified women economists for appointments in the next Administration. Access to the roster of women in economics was offered to both parties.

The founding convention of a National Women's Studies Association, hosted by the Women's Studies Program at San Jose State University will be held January 13-16 1977 in San Francisco. The aim of the national organization is to provide and

encourage non-sexist, non-racist feminist education in traditional and non-traditional areas of education. Individuals committed to Women's Studies in a variety of educational settings -- Women's Centers, Post-Secondary Women's Studies Programs, Women's Prison Projects, Centers for Research on Women, Elementary and Secondary Schools, Women's Re-Entry Programs, and Vocational Projects for Women, among others -- will be attending the meeting.

Task forces, workshops, and panels on the practical problems facing Women's Studies and the substance of feminist education and culture will be held.

Dr. Mary Rowe of the President's office of MIT and Dr. Hilda Kahne, Associate Director of Radcliffe Institute were the CSWEP delegates to the annual meeting of the Federation of Organizations for Professional Women held at Wellesley College, November 5th and 6th. The topic of the meeting was "Upward Mobility for Women in Business and Industry." Business representatives met with delegates to discuss mutual accomplishments and needs related to increasing the numbers of women in middle and top management positions in corporations.

Hilda Kahne is preparing a review of economic research on the status and roles of women, completed or in progress during 1976 or 1977 for Signs Magazine. She hopes to emphasize research on work and family and other new directions in issues and research methods. Women economists, particularly those with TIAA-CREF Retirement Plans, will be interested in the article from Committee W of AAUP, "Interim Report on Equal Periodic Pension Benefits for Men and Women", published in the Autumn 1976 issue of AAUP Bulletin, pp. 339-342. This article lays out clearly the reasons for using sex-neutral mortality tables.

The National Commission on the Observance of International Women's Year is now offering a Newsletter, a Press list, a Women in World Newsletter, and a IWY Report entitled "To Form a More Perfect Union: Justice for American Women." To obtain these materials write the Commission at: Room 1004, Department of State, Washington, D. C. 20520. The Commission will sponsor fifty-seven State and Territorial meetings concerning women's rights and responsibilities. A national conference will be held in November, 1977. The Commission has also released the first fifty planned booklets on the legal status of homemakers in each of the States and District of Columbia. The first one (Louisiana; stock number 0040-000-00359-2) from the Government Printing Office, Washington, D. C. 20402.

A new Civil Service Bulletin details "Career Counseling for Women in the Federal Government." Volunteer work can now be included and evaluated in job experience. "...in examinations where experience is a factor, credit will be granted for any pertinent religious, civic, welfare, service organizational service ..." The applicant should include only volunteer service pertinent to the job under consideration.

Should universities be compelled to remedy sex discrimination by setting numerical hiring goals for women faculty members? Opponents of these goals, required by the Department of Health, Education and Welfare, insist on tagging them as "quotas." Why?

Those who insist that today's hiring goals be called "quotas" imply that the goals, like yesterday's quotas work against impartiality. But that claim is false, H.E.W.-approved goals for women instructors serve not to restrict but to extend impartiality. Women who by a merit standard deserve faculty appointments will no longer be excluded by sex bias.

It is significant that since the advent of anti-bias regulations sex discrimination has disappeared in an area where it is not easily hidden: Salary inequities between men and women instructors at the beginning of their academic careers have now been wiped out.

Universities are now excused by the Department of Health, Education, and Welfare from meeting their goals if they can show what the Labor Department calls "good faith" efforts to find qualified women (advertising jobs, contacting women's professional groups, inviting women to apply, etc.). Opponents of goals claim that such "good faith" efforts should suffice to end university sex discrimination. But their claim is challenged by recent reports from affirmative-action specialists, of "good faith" efforts that are a sham. (A department, for example, first selects the man it wants for the job, then pretends to search for candidates.) Such reports are corroborated by studies showing that women are running a close second to blacks in having the highest unemployment rate among 1974 and 1975 doctoral recipients.

It is not the hiring goals, but the "good faith" efforts, that need critical scrutiny.



We apologize for the delay in replying to your letter of March 12, but we wanted to convey a consensus that our diverse schedules conspired against until now.






