COMMITTEE ACTIVITIES

CSWEP members met in Cambridge at M.I.T. on October 12. Those attending were Ann Friedlaender, Mariam Chamberlain, Marianne Ferber, William Hellmuth, Barbara Jones, Helen Ladd, Ruth Shaeffer and Robert Solow. Also attending were Elizabeth Bailey, the next incumbent of the Committee Chair, and Janet Goulet, CSWEP regional representative for the Midwest. Ann Friedlaender chaired the meeting and Ruth Shaeffer served as recording secretary.

The first item on the agenda was the budget. Due to rising costs, particularly roster expenses, the current budget is not sufficient to cover the activities of the Committee for the full year. Accordingly it was decided to take the following steps: (1) to request supplementary support from the Association for 1979, (2) to request an increase in the next annual budget, (3) to increase the charge for the roster to \$50 for non-profit institutions and \$75 for others, and (4) to increase membership dues to \$5. For the next meeting Marianne Ferber will conduct an overall review of roster operations, including the costs of recent improvements, and develop a projected budget for next year on a steady-state basis.

The Committee then turned to plans for the Atlanta meeting. Activities are going forward with regard to the sponsorship of an advertisement about the ERA in the Atlanta

Constitution at the time of the AEA annual meetings. It was agreed that the ad should run on Friday, December 28th. A copy of the ad is shown on page 19. Names will be listed in alphabetical order and state of residence but no institutional affiliation will be shown. Bill Hellmuth is coordinating the ad campaign. Since the ad is expensive (ranging from \$1,500 for a quarter page to \$6,000 for a full page) we will need a large number of signatures and contributions. You can assist us in this effort by circulating the attached advertisement to get as many signatures and contributions as possible from faculty, students, research and professional staff, etc. We are asking for contributions between \$1 and \$5. Other CSWEP activities related to the ERA at the time of the Atlanta meetings are the following. There will be a session entitled Women's Place in the Labor Market: Will ERA Matter? This session will take place Friday, December 28 at 10:15 A.M. at the Hilton Hotel. It will be chaired by Marianne Ferber and the papers to be presented are: 'Comparable Worth and ERA,' by Heidi I. Hartmann, National Academy of Science; 'The Likely Impact of ERA on Women's Economic Status,' by James Heckman, University of Chicago; and 'Prospects for Women's Earnings: The Role of Policy and the Market,' by Frank P. Stafford, University of Virginia. The discussants will be Andrea Beller, University of Illinois, Urbana; Michael Reich, University of California, Berkeley; and Myra Strober, Stanford University.

Also on Friday, the 28th, will be a CSWEP Open Business Meeting, scheduled at 4:30-6:00 in the afternoon.

The CSWEP-sponsored session on The Consequences of the Growth of the Two-Earner Family will take place on Saturday, December 29 at 10:15 A.M. Papers and discussants for this session were listed in the last Newsletter. The meeting will be chaired by Janet Goulet of Wittenberg University.

In lieu of an ERA luncheon, there will be an ERA Reception and Cash Bar on Saturday the 29th from 5 to 7 P.M. in the Forsythe Room of the Hilton Hotel.

The CSWEP Hospitality Suite will be open from 9 to 5 on Friday and Saturday. It will be located in the George Washington Room of the Hilton Hotel. Barbara Jones will handle the local arrangements and Joan Haworth will help staff the suite. Betsy Bailey will look into the possibility of having a CSWEP booth in the ASSA registration area at which CSWEP materials, including those relating to ERA activities, would be available. In any event, ERA literature and buttons will be available in the hospitality suite and at the Reception.

CSWEP activities with regard to the ERA are being coordinated insofar as possible with those of URPE (Union for Radical Political Economics), which has also decided to participate in the Atlanta meetings in order to focus attention on ERA both within the AEA

and in the Georgia community. URPE is cooperating with CSWEP in supporting the newspaper ad. In addition, URPE is planning a series of panel sessions and seminars on economic sexism and racism. Approximately fifteen panels are being organized on topics including the following:

Women and Minorities in the Current Economic Crisis
Household Decision-Making and the New Home Economics
Health Care, the Fiscal Crisis and the Implications for Women
and Minorities
The Political Economy of 'Women in Development'
Theoretical Developments in the Analysis of Women's Subordination
The New International Division of Labor and the Division of Labor
by Sex
The Sraffa Controversy over Prices of Production and its Implication
for the Analysis of Domestic Labor
Gender and Race in Economic History

In addition to the panels, two seminars will be held daily during the course of the Convention on "The Political Economy of Women" and "The Political Economy of Discrimination by Race and Sex", which will be open to the Atlanta Community.

URPE plans for Atlanta include two other activities. (1) A resolution will be presented at the business meeting of the AEA prohibiting future meetings in non-ERA ratified states and requiring formal notification of the political leaders of each non-ratified state of that resolve. (2) A demonstration is planned, perhaps in conjunction with Georgia ERA advocates, outside the convention. No further details about these activities are available at the present time.

The new CSWEP membership for 1980 will be as follows. As previously noted, Betsy Bailey will take over as Chair, replacing Ann Friedlaender. Also rotating off the Committee will be Mariam Chamberlain, Bill Hellmuth and Ruth Shaeffer. Joining the Committee will be Louise Curley, Vice President for Economics at Scudder, Stevens and Clark; Nancy Rugges, Assistant Director of the Statistical Office at the United Nations; Robert Eisner, Professor of Economics at Northwestern University; and ex-officio, as President of the American Economic Association, Moses Abramovitz of Stanford University.

The topic for the CSWEP-sponsored session at the 1980 AEA meeting to be held in Denver in September will be The Impact of Current Inflation on Women and Minorities, as announced in a postcard mailing to all members earlier this fall. The due date for submission of papers was November 1. Further details about the program will be provided in the next Newsletter.

CONFERENCES AND CALL FOR PAPERS

The Center for the Social Sciences at Columbia University, Program in Sex Roles and Social Change, is planning a conference on Women in Third World Countries for the Fall 1980. The aim is to work toward a unified perspective from Economics and Anthropology; to bring together household-focussed and nation-focussed theories and empirical findings. GRANTS AND GRANT OPPORTUNITIES

The American Association of University Women Educational Foundation awards dissertation and postdoctoral fellowships to women of the United States who have achieved distinction or promise of distinction in their fields of scholarly work. There are no restrictions as to age of applicant, academic field or place of study. Great importance is attached to the project on which the applicant wishes to work, its probable significance as a contribution to knowledge and the applicant's qualifications to pursue it. Period of award: Twelve months beginning July 1, 1980. Stipends: \$3,500-\$7,000 (up to \$9,000 for postdoctoral fellowships). Fellowships are also offered to assist women in their final year of professional training in selected professions -- law, dentistry, medicine, veterinary medicine and architecture. Full text of the amendment:

Section 1. EQUALITY OF RIGHTS UNDER THE LAW SHALL NOT BE DENIED OR ABRIDGED BY THE UNITED STATES OR BY ANY STATE ON ACCOUNT OF SEX.

Section 2. THE CONGRESS SHALL HAVE THE POWER TO ENFORCE, BY APPROPRIATE LEGISLATION, THE PROVISIONS OF THIS ARTICLE.

Section 3. THIS AMENDMENT SHALL TAKE EFFECT TWO YEARS AFTER THE DATE OF RATIFICATION.
