We use the roster as the best current estimate of the number of women economists, AEA member or not. We also use it as the mailing list for this Newsletter. From it, we make up lists of various subsets of women economists by field, etc. to answer requests for names of women economists that program chairmen, employers, etc. may wish to contact to determine interest and ask for vitae. We do this to widen the market and improve the information network.

VICTORIA C. LAPHAM FELLOWSHIP IN ECONOMICS

This new fellowship has been funded in memory of Victoria C. Lapham by her husband. The purpose of the fellowship is to encourage and assist a woman with a bachelor's degree in anthropology, political science, psychology, or sociology to take up graduate studies in economics. Applicants must be U.S. citizens, and plan to study at an accredited graduate school in the U.S. (The graduate school is to be chosen by the recipient.) The fellowship pays tuition and fees and a stipend of \$2,250 for one academic year. Application forms may be obtained on request from the Fellowship Committee, Department of Economics, Southern Methodist University, Dallas, Texas 75275. Please encourage outstanding women in the other social sciences to consider becoming economists to apply for this fellowship.

THE 1975 MEETING OF THE AMERICAN ECONOMIC ASSOCIATION will be held October 2nd through 4th in Dallas, Texas. POLICY RESEARCH CENTER ESTABLISHED

A new Center for Research on Women in Higher Education and the Professions has been established at Wellesley College. The Center is sponsored jointly by the College and the Federation of Organizations for Professional Women, a federation of more than 55 women's professional associations, including CSWEP. The Center is funded by a grant of \$195,000 from the Carnegie Corporation, and will be directed by Carolyn M. Elliott, a political scientist from the University of California.

Among the first projects of the Center will be a conference on Occupational Segregation, to be held in May, 1975, in conjunction with CSWEP. Other activities planned are an intervention project on the teaching of mathematics to high school and college women, which will develop new teaching techniques to overcome women's feelings of incompetence in studying math, and a conference to familiarize women administrators in higher educational institutions with budgeting and financial management. The Center is now also developing plans for major research projects on alternative entry routes into the professions and on flexibly-scheduled careers. Finally, it hopes to offer facilities to scholars bringing their own research projects on women.

TIAA-CREF

Many of you have voiced complaints about the present system of unequal College Retirement Equities Fund periodic retirement benefits. It has been learned that the Teachers Insurance and Annuity Association has agreed to prepare an equal periodic benefit plan for men and women to be offered as an option to universities. You may want to support the adoption of such an alternative by your own institution.
