

## Disclosure for David Phillips

### High Schools Tailored To Adults Can Help Them Complete a Traditional Diploma and Excel in the Labor Market

1. The Lab for Economic Opportunities received a grant of \$9,928 from Goodwill of Central and Southern Indiana ending in 2018 for work other than this project. It covered on a separate project studying the interrelationship of their Nurse Family Partnership and Excel Center Programming.

This project also received support from Policy Impacts at Harvard University. Patrick Turner received a \$20,000 Early Career Scholars Grant in 2021 to support the analysis of the marginal value of public funds (MVPF) for the Excel Center, as well as two other interventions.

2. The author has not received significant financial support from an interested party summing to at least \$10,000 in the past three years.

3. David Phillips is a board member of the Beacon Resource Center, a non-profit community center that provides space to organizations in South Bend, IN, including an adult education program.

4. No other disclosures apply to any close relative or partner of any author.

5. Goodwill Education Initiatives had the right to review this paper only for privacy concerns. The relevant text from our data sharing agreement is as follows:

Nothing in this DSA shall be interpreted to grant Goodwill any right, title or interest in LEO intellectual property that has been or will later be developed outside the scope of services provided hereunder.

Unless otherwise directed by Goodwill, any publication resulting from these data must indicate that the client data were provided by the Parties and must include a disclaimer to the effect that published material does not necessarily reflect the views of Goodwill.

All materials to be published shall first be submitted to Goodwill at least 30 days prior to publication or other disclosure. Upon written objection from either of the Parties, LEO shall excise any confidential information, as that term is defined in this DSA, from materials before the publication.

Goodwill may also object to the publication on grounds other than confidentiality. As to the objections, the Parties will attempt to resolve the concerns within the 30-day review period, or as otherwise agreed between the parties. The Parties waive rights to any objections not made to LEO in writing before expiration of the review period. If the Parties' objections on grounds other than confidentiality are not resolved within the review period or such other time agreed by the parties, then LEO may publish the materials but shall include therein the following disclaimer: "Although the research or system support underlying this article were provided in whole or in part by Goodwill, Goodwill does not endorse or adopt the opinions or conclusions presented in this article." Notwithstanding the above, Goodwill shall not have the right to control or censor the contents of LEO publications.

For any publication resulting from these data, LEO will create a de-identified dataset of individual records. This dataset will include all data necessary to replicate the published work except that any variables that may individually or jointly identify individual Participants will not be included. At the time LEO submits any research to Goodwill, LEO will transfer this dataset to Goodwill who may share it with community stakeholders. LEO may distribute this dataset publicly to the academic research community.

The Indiana Management Performance Hub had the right to review the results for privacy concerns but not the final paper.
